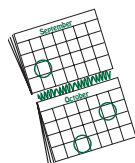

Financial Planning Information

Comparing your Retirement Plan Options

Retirement plan contributions made for yourself and your workers are generally tax deductible as a business expense. Offering one of these retirement plans could help you shelter more of your income from taxes and build wealth outside of your business. It might also be an effective way to reward and help retain valuable employees.

401(k) plan. Some 401(k) plans are becoming easier and less expensive for small firms to set up and maintain. Owners can often make large contributions for themselves (as employee and employer) in exchange for making contributions or “matches” for employees.

The maximum employee contribution is \$18,000 (\$24,000 for those 50 and older) in 2016. The required match is a minimum 100% of each participant's first 3% of salary plus 50% of the next 2% of salary, or a non-elective contribution equal to 3% of salary for all eligible employees. A match or profit-sharing contribution up to 100% of an employee's compensation is allowed, up to a \$53,000 cap (from both sources, not including catch-ups) in 2016.

With a solo 401(k), a business owner with no employees can make a contribution up to the \$18,000 employee limit (\$24,000 for those 50 and older). As employer, the business can contribute an additional 20% of the owner's compensation (25% if incorporated), up to the \$53,000 cap.

SEP IRA (simplified employee pension). A SEP IRA may be a good choice for self-employed individuals, business owners who want to maximize contributions, and small businesses with mostly lower-paid employees. The same percentage of salary (up to 25% of compensation or \$53,000) must be contributed to each eligible employee's SEP IRA, including the owner's. The business is not required to contribute every year. Self-employed individuals can contribute 20% of net earnings, up to \$53,000 in 2016.

SIMPLE IRA. Companies with 100 or fewer employees may use a SIMPLE IRA salary-reduction plan, which requires little or no paperwork. The maximum employee contribution in 2016 is \$12,500 (\$15,500 for those

50 and older). The required match is 100% of the first 3% of participant's contribution or 2% of all eligible employee salaries.

Distributions from employer-sponsored retirement plans are taxed as ordinary income. Withdrawals prior to age 59-1/2 may be subject to a 10% federal income tax penalty. Early withdrawals from a SIMPLE IRA (prior to age 59-1/2) during the first two years of participation may be subject to a 25% penalty; 10% thereafter.

- **Lighting:** Interior and exterior LED as well as reduced wattage T8 or T5 linear fixtures. LEDs typically use 25–80% less energy than traditional incandescent bulbs and can last up to 25 times longer, saving on maintenance and operating costs.
- **HVAC:** Comfort systems including high-efficiency air conditioners, heat pumps and demand-controlled ventilation units, all on a per-ton basis. Rebates are also available for retrocommissioning, the process of ensuring HVAC systems are designed, installed and maintained according to operational specifications. Retrocommissioning can cut energy bills by 10–15%.
- **Compressed air systems:** New high-efficiency compressors and various equipment that prevent air loss such as air-entraining air nozzles. New models of compressed air equipment save energy while limiting moisture.
- **Controls:** Energy management systems, otherwise known as building automation systems, as well as lighting sensors. Energy management systems can yield savings of more than 30% in older or poorly maintained buildings through the centralized control of HVAC, lighting and other building systems.
- **More:** Data center upgrades, refrigeration equipment and custom retrofit measures.

He is also an Attending in Oral Medicine at the Hospital of the University of Pennsylvania and a University Associate at the Children's Hospital of Philadelphia. He completed his DMD degree program at the University of Pennsylvania, School of Dental Medicine where he graduated with honors. He is a Fellow in Hospital Dentistry and a Diplomate in Special Care Dentistry and a Diplomate in Oral Medicine. Formerly, he was the Director of the Oral Medicine Residency Program and formerly served as the Interim Dean at the University of Pennsylvania, School of Dental Medicine. He served as President of the Eta Chapter of OKU and President of the American Academy of Oral Medicine. He is a Section Editor of the Compendium Journal, and he is a reviewer for the Journal of the American Dental Association and is presently serving on the ADA Council of Scientific Affairs. He has authored numerous papers and chapters related to various topics in Oral Medicine.
