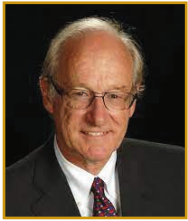

Happy New Year! As we enter February of a license renewal year, it is time to make sure that we have fulfilled our continuing education requirements. All dentists are required to complete 30 hours of continuing education each renewal cycle, and we must remember that only 50% of these hours can be from pre-recorded lectures or self-study. At least two (2) hours of continuing education must be on Recognizing Child Abuse (Act 31), and for those with a DEA license, two (2) hours of continuing education must be on Opioid Abuse (Act 124). # About Screening, Brief Intervention & Referral to Treatment (SBIRT)

*Healthcare providers can reduce the impact of substance misuse, abuse and addiction with cost-effective screening and brief intervention.*

Substance misuse, abuse and addiction contribute to a wide range of health-related problems, and lead to extensive legal, financial and emotional consequences for individuals, families and society. Healthcare providers are in a prime position to reduce these negative outcomes. Yet many healthcare providers report that addressing alcohol and other drug problems is one of the most challenging areas of their practice.

## SBIRT can help

The evidence-based practice of Screening, Brief Intervention & Referral To Treatment (SBIRT) can be part of the solution. The first component of SBI is a valid and reliable short screen that can be administered in a variety of ways, followed by a brief intervention (as few as 3 minutes), if needed, based on the results of the screen. The brief intervention includes feedback about the screening results (what they mean for the patient and his/her health), concrete advice based on medical concern and low-risk guidelines, and support for the decision of the patient. If a persons screening places them in the “high risk” category, Referral to Treatment is provided to the person as an option.

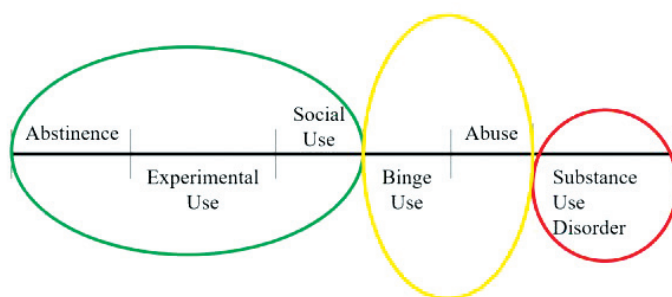
SBIRT views substance use as a continuum (see below), not just a matter of being “addicted” or “not addicted.” It targets individuals who are using alcohol or other drugs in hazardous or harmful ways, but who are not dependent. Many people do not even know that they may be engaging in behaviors

that put them and others at risk. These individuals have the ability to modify their behavior with feedback, information, advice and support. Of course, the process also identifies those in need of specialized treatment and can assist in motivating these patients to seek the help they need. Increasing data show that this brief process is cost-effective and reduces alcohol and other drug

use and associated harm.

Looking at the Continuum Model below, the area highlighted in green is viewed as “low risk drinking”, the area highlighted in yellow is viewed as “moderate risk” and “high risk”. The area highlighted in red is viewed as “problematic use”. With this continuum model, the goal of SBIRT is to eliminate or reduce the amount of time a individual spends in the yellow highlighted area. By eliminating the yellow highlighted area, the individual greatly reduces the likelihood of ending up in the red highlighted area with problematic use.

## HHS warns health care providers of new ransomware threat ADA offers tips to help dentists protect data

Ransomware responsible for an increasing number of attacks in 2022 could pose a threat to the dental community.

The Health Sector Cybersecurity Coordination Center of the U.S. Department of Health and Human Services released information Dec. 7 about Royal, a human-operated ransomware first seen in 2022 that has demanded ransoms of more than \$2 million.

“Due to the historical nature of ransomware victimizing the healthcare community, Royal should be considered a threat to the [health care and public health care] sector,” the Health Sector Cybersecurity Coordination Center stated in its note posted to the HHS website.

Royal attacks impacting the health care sector have primarily targeted organizations in the U.S., and in each instance, the attackers claim to have published all of the data they allegedly extracted from the victim.

In addition to using attack methods frequently associated with ransomware, such as phishing;

remote desktop protocol compromises and credential abuse; compromises of exploited vulnerabilities, such as VPN servers; and compromises in other known vulnerabilities, Royal has employed new techniques and evasion tactics, including embedding malicious links in Google ads, using an organization’s contact forum to bypass email protections and placing malicious installer files on legitimate-looking software sites.

**The ADA offers several tips to help member dentists protect themselves against cyberattacks.**

**Steps include training staff on basic data security; backing up data regularly and keeping an encrypted copy off-site; being wary of attachments and web links included with suspicious emails; and maintaining cyber defenses, such as anti-virus and anti-malware software.**

The ADA also offers continuing education courses on ransomware readiness and phishing and ransomware

### Watch Out for These Common Tax Scams

**According to the Internal Revenue Service (IRS), tax scams tend to increase during tax season and/or times of crisis.<sup>1</sup> Now that tax season is in full swing, the IRS is reminding taxpayers to use caution and avoid becoming the victim of a fraudulent tax scheme. Here are some of the most common tax scams to watch out for.**

#### Phishing and text message scams

Phishing and text message scams usually involve unsolicited emails or text messages that seem to come from legitimate IRS sites to convince you to provide personal or financial information. Once scam artists obtain this information, they use it to commit identity or financial theft. The IRS does not initiate contact with taxpayers by email, text message, or any social media platform to request personal or financial information. The IRS initiates most contacts through regular mail delivered by the United States Postal Service.

#### Phone scams

Phone scams typically involve a phone call from someone claiming that you owe money to the IRS or you're entitled to a large refund. The calls may show up as coming from the IRS on your Caller ID, be accompanied by fake emails that appear to be from the IRS, or involve follow-up calls from individuals saying they are from law

enforcement. These scams often target more vulnerable populations, such as immigrants and senior citizens, and will use scare tactics such as threatening arrest, license revocation, or deportation.

#### Tax-related identity theft

Tax-related identity theft occurs when someone uses your Social Security number to claim a fraudulent tax refund. You may not even realize you've been the victim of identity theft until you file your tax return and discover that a return has already been filed using your Social Security number. Or the IRS may send you a letter indicating it has identified a suspicious return using your Social Security number. To help prevent tax-related identity theft, the IRS now offers the Identity Protection PIN Opt-In Program. The Identity Protection PIN is a six-digit code that is known only to you and the IRS, and it helps the IRS verify your identity when you file your tax return.

#### Tax preparer fraud

Scam artists will sometimes pose as legitimate tax preparers and try to take advantage of unsuspecting taxpayers by committing refund fraud or identity theft. Be wary of any tax preparer who won't sign your tax return (sometimes referred to as a "ghost preparer"), requires a cash-only payment, claims fake deductions/tax credits, directs refunds into his or her own account, or promises an unreasonably large

or inflated refund. A legitimate tax preparer will generally ask for proof of your income and eligibility for credits and deductions, sign the return as the preparer, enter a valid preparer tax identification number, and provide you with a copy of your return. It's important to choose a tax preparer carefully because you are legally responsible for what's on your return, even if it's prepared by someone else.

#### False offer in compromise

An offer in compromise (OIC) is an agreement between a taxpayer and the IRS that can help the taxpayer settle tax debt for less than the full amount that is owed. Unfortunately, some companies charge excessive fees and falsely advertise that they can help taxpayers obtain larger OIC settlements with the IRS. Taxpayers can contact the IRS directly or use the IRS Offer in Compromise Pre-Qualifier tool at [irs.treasury.gov/oic\\_pre\\_qualifier/](https://irs.treasury.gov/oic_pre_qualifier/) to see if they qualify for an OIC.

#### Unemployment insurance fraud

Typically, this scheme is perpetrated by scam artists who try to use your personal information to claim unemployment benefits. If you receive an unexpected prepaid card for unemployment benefits, see an unexpected deposit from your state in your bank account, or receive IRS Form 1099-G for unemployment compensation that you did not apply for, report it to your state

unemployment insurance office as soon as possible.

**Fake charities**

Charity scammers pose as legitimate charitable organizations in order to solicit donations from unsuspecting donors. These scam artists often take advantage of ongoing tragedies and/or disasters, such as a devastating tornado or the COVID-19 pandemic. Be wary of charities with names that are similar to more familiar or nationally known organizations. Before donating to a charity, make sure it is legitimate and never donate cash, gift cards, or funds by wire transfer. The IRS website has a tool to assist you in checking out the status of a charitable organization at [irs.gov/charities-and-nonprofits](https://irs.gov/charities-and-nonprofits).

**Protecting yourself from scams**

Fortunately, there are some things you can do to help protect yourself from scams, including those that target taxpayers:

- Don't click on suspicious or unfamiliar links in emails, text messages, or instant messaging services — visit government websites directly for important information
- Don't answer a phone call if you don't recognize the phone number — instead, let it go to voicemail and check later to verify the caller
- Never download email attachments unless you can verify that the sender is legitimate

- Keep device and security software up-to-date, maintain strong passwords, and use multi-factor authentication
- Never share personal or financial information via email, text message, or over the phone

- Understand the legal responsibilities as mandated reporters.
- Know when, how and where to report suspected abuse, and what happens after a report is made.
- Understand the protections for reporters and penalties for failure to report.

**DR. 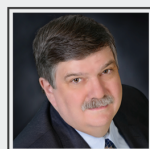

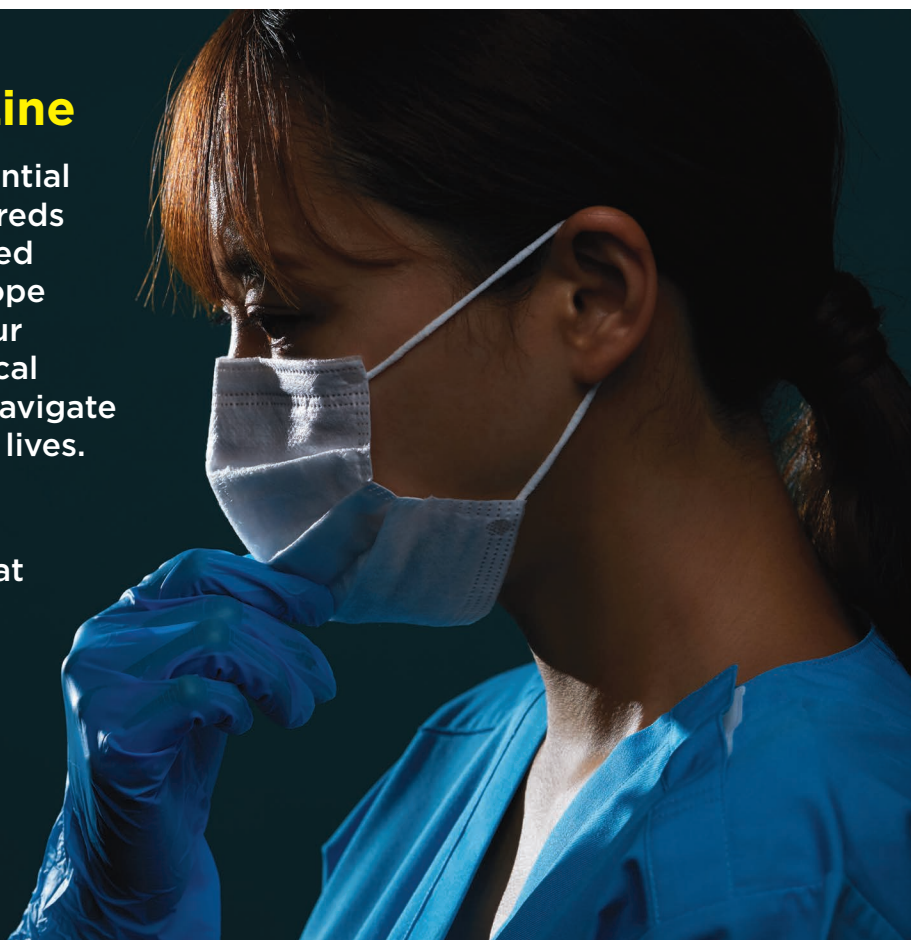

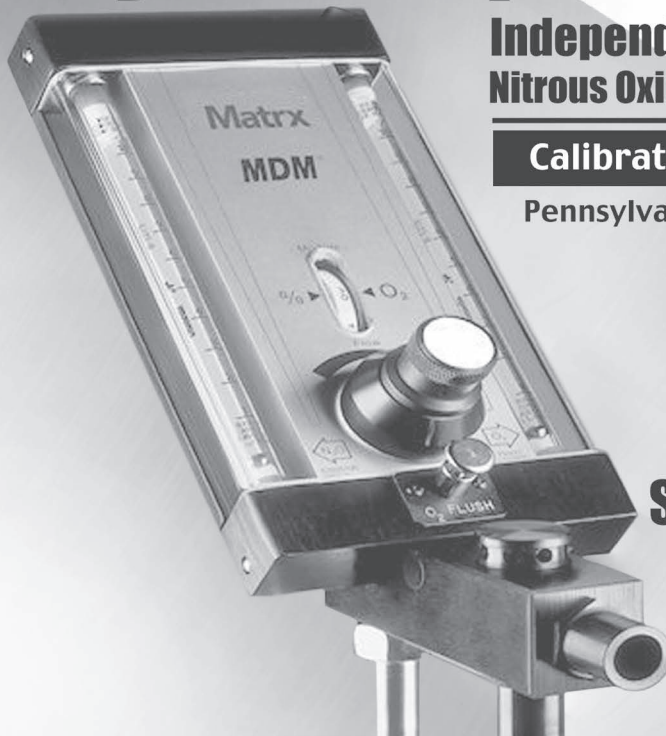

Peter Hunt is a fourth generation dentist trained originally in Great Britain. He received his Dental degrees from Guy's Hospital Dental School. After graduation he became one of two dental Resident House Surgeons at Guy's Hospital. He then became Resident House Surgeon at the prestigious Maxillo-Facial unit of Queen Victoria Hospital in East Grinstead under Sir Terence Ward. Peter then switched disciplines and received a Master's Degree in Advanced Restorative Dentistry from the Eastman Dental Hospital in London. He received a Scholarship from Walter Annenberg, the American Ambassador in Great Britain to study at the University of Pennsylvania where he received Specialty certificates in both Periodontics and Periodontal Prosthesis.

He has always been interested in teaching dentistry which started first in first in Cape Town, South Africa where he was Senior Lecturer at the University of the Western Cape and at the same time he held a similar position in Periodontics at the University of Stellenbosch. These schools were later merged at the end of apartheid. Then he was recruited back to the University of Pennsylvania, where he became Director of the Foreign Dental Training Program, later Director of Continuing Education and later still, Clinical Professor of Periodontics.

He was then recruited to help with another start up this time in Florida in the Dental School of Nova SouthEastern University in Fort Lauderdale, USA. There he was Professor of Restorative Dentistry, Post-Graduate Director, and Director of Periodontal Prosthesis and Implant Dentistry. He also provided undergraduate programs on Dental Materials, Occlusion and Implantology.

Peter first started placing and restoring dental implants in the 1980's. Over the years his practice has become more and more devoted to implantology. He has lectured widely at implantology meetings in the United States and Canada many other countries.

He is the Founder and Editor of [ImplantsConnect.com](http://ImplantsConnect.com), a website with case reports and videos from multiple contributors around the world. This material is readily available at no charge to the viewer.

Over the years he has been a consultant and/or lecturer for more than 20 different dental companies. These most recently include Camlog in Switzerland in relation to implantology, 3 Shape in Denmark in relation to a digital workflow, surgical guide design, production of abutments as well as design and manufacture of final restorations. He has recently been commissioned by Geistlich to produce two on-line continuing education programs, one on Immediate Placement Anterior Implant therapy and the other on Immediate Placement Posterior Implant Therapy. These are going to be translated into multiple languages.

He has had a private practice in the heart of Philadelphia since 1981, which has allowed him the opportunity to provide inter-disciplinary dentistry in a manner that gives great satisfaction to him personally and allows him the opportunity to continue to improve his skillset with the most modern technology available.
