Oral Cancer & Potentially Malignant Disease: An Update

Presented by:

### Thomas P. Sollecito, DMD

This lecture will review oral cancer and oral potentially malignant disease (OPMD) that maybe encountered in daily practice. We will review risk factors for oral cancer and OPMD. The lecture will review the complexities in the detection and diagnosis of oral potentially malignant disease, and review current surgical and non-surgical treatment strategies in treating those diseases. Finally, this course will provide guidance on the dental evaluation prior to anticipated cancer treatment and describe the dental management of the oral cancer patient including long-term follow-up.





## MBDS Patient Relations Committee

Did you know that the Montgomery Bucks Dental Society has a Patient Relations Committee? We are the last dental society in the state to have such a program.

For many years patients who had a complaint about dental care could contact the PDA and would be referred to the proper local dental society. Volunteers at the local level would investigate the complaint and then

try to mediate between the patient and dentist. This was a win-win situation for everyone. This type of resolution avoids lawyers, courts and the State Board of Dentistry. Most importantly, it was a free member benefit.

Sadly, the world got to be a more complicated place. Not all dentists are members of the PDA.

Patients and dentists were unwilling to compromise. Some locals and their volunteers were threatened with legal action from either party. Slowly the PDA and the locals discontinued their patient relations committees.

Montgomery Bucks Dental Society has discussed this member benefit several times. Each time, the Executive Committee renews the committee and its purpose.

Dr. Bruce Terry is the long-time Chairperson replacing Dr. Robert Singer. Dr. Terry gives a report on recent activity at each executive committee meeting. In the past year he has helped with three cases.

Each case was brought to the committee by a patient. Patients may hear about us after calling or emailing the PDA or Dr. Howley directly. The patient may have transferred to a new dentist and upon hearing the patient's story the dentist may refer the patient to Dr. Howley.

Each patient has a similar story. Dental work was provided, and the outcome was either not what the

patient expected, or it may not have met with their satisfaction. It is more often about communication and poorly aligned expectations between the patient and the dentist. It's almost never about standard of care; those types of cases will usually go to the State Board of Dentistry or to a lawyer.

The committee has no weight and cannot fine, compel or sanction a dentist. We have no authority other than

to act as an arbitrator. Most often we listen. We will gather the information from the patient and the dentist. If needed, we will ask the patient to come to a third-party dental office for an examination to determine what might be needed to help the patient. Other times we discuss the situation with the dentist, and they may be able to help the

patient directly. This may be accomplished by redoing work or refunding the patient to have work done elsewhere. All of this is again voluntary and if the dentist does not want to participate, they can decline. It's always our recommendation the dentist and patient communicate and try to resolve their differences.

The Montgomery Bucks Dental Society will continue with this program because we see it as a valuable member benefit. We feel that patients deserve to be heard without having to file a lawsuit, and if we can prevent legal action, we have done a service to the dentist and the patient.

Next time you encounter a patient who has unkind things to say about a prior dentist and asks you if they should hire a lawyer, encourage them to contact Montgomery Bucks Dental Society and request help with a dispute regarding their dental care.

### Dental workforce transitioning to younger, female dentists

New HPI report shows nearly 2 in 5 dentists are female

more female workforce, according to a new report from the ADA Health Policy Institute.

In 2024, nearly 2 in 5 dentists in the U.S. were female, according to The U.S. Dentist Workforce – Update 2025. The share of dentists who are female has more than doubled since 2001, increasing from 35 and under are female as of 2024.

"A younger and more diverse workforce means that the shift from solo practice to group practice and dental support organizations, a trend that has been underway for a decade, will continue. Younger dentists are delaying practice ownership and are It also includes state-level trends. more frequently practicing in group practice after graduation," said Marko Vujicic, Ph.D., ADA chief economist and vice president of HPI.

According to the report, while the dental workforce ADA.org/hpi. is changing in terms of demographics and practice


The face of dentistry is changing to a younger and modality, established dentists are experiencing a "fiscal squeeze" that is driving income down across all specialties and career stages. Dentists are also retiring later than they used to.

The supply of dentists has been stable for the past few years but is about to grow, Dr. Vujicic said. The retirement "surge" among baby boomer dentists is 16% to 39%. In addition, about half of dentists ages nearing its end while dental school enrollment is at an all-time high.

> The new HPI report explores trends in four domains: who makes up the dentist workforce, how and where dentists work, how practicing dentists are doing economically, and the future of the dentist workforce.

Upon completion of this course, participants should be able to:

- Evaluate the oral cavity and diagnose oral cancer and oral potentially malignant disease.
- Understand risk factors and epidemiology for oral cancer/oral potentially malignant disease.
- Discuss the current rise of HPV and its impact on the prognosis and management of oropharyngeal
- Discuss surgical and non-surgical treatment strategies of oral cancer/oral potentially malignant
- Manage appropriate pre cancer treatment referrals.
- Describe the management and long term follow up of the oral cancer patient.

Dr. Thomas Sollecito is the Professor and Chair of Oral Medicine at the University of Pennsylvania, School of Dental Medicine and Professor of Oral Medicine in Otolaryngology: Head and Neck Surgery, University of Pennsylvania School of Medicine. He is also an Attending in Oral Medicine at the Hospital of the University of Pennsylvania and a University Associate at the Children's Hospital of Philadelphia. He completed his DMD degree program at the University of Pennsylvania, School of Dental Medicine. He is a Fellow in Hospital Dentistry and a Diplomate in Special Care Dentistry and a Diplomate in Oral Medicine. Formerly, he was the Director of the Oral Medicine Residency Program and formerly served as the Interim Dean at the University of Pennsylvania, School of Dental Medicine. He is a Section Editor of the Compendium Journal, a reviewer for the Journal of the American Dental Association and served on the ADA Council of Scientific Affairs. He has authored numerous papers and chapters related to various topics in Oral Medicine.


